## **MADISON AVENUE TOWNHOMES**

The newly constructed Madison Avenue Townhomes transformed two blighted, vacant lots in the City of Scranton into safe affordable housing. Completed in 2018, these two-bedroom townhomes provide critically needed housing for participants in Geisinger's LIFE program. The LIFE program is a nursing home prevention program which enables seniors to live independently by providing much-needed services and programming. This development created a partnership between UNCDC, LIFE Geisinger, the City of Scranton, the Lackawanna County Land Bank, and the Pennsylvania Housing Finance Agency.



#### **LEHIGH COAL & NAVIGATION BUILDING**



The renovations of the Lehigh Coal and Navigation Building were presented at a Grand Opening ceremony that was held in May of 2018.

The residents of the building gladly welcomed community leaders and all of the guests who helped make this rehabilitation possible.

## **HBS MANAGEMENT COMPANY**

In 2018, UNCDC formed HBS Management Company to oversee the property management of three high rise senior buildings, which are located in Eastern Pennsylvania. Amos Towers is a 95-unit senior building, located at 525 Jefferson Avenue in Scranton, that underwent multiple upgrades in 2018; including the addition of a new gazebo and the rehabilitation of its administrative offices.

Webster Towers is an 87-unit senior building, at 500 North Webster Avenue in Scranton, which will undergo a major facelift in 2019. It is planned that all of the original windows will be replaced with new, easier to open, energy saving windows and many kitchens will be replaced. The final property that is managed by HBS Management is the B'nai B'rith Apartments in Reading, Pennsylvania. This 170 unit senior building will also see continued improvements in the coming year including elevator and HVAC upgrades.

#### **DEVELOPMENT PLANS FOR 2019**

UNCDC will finally break ground in early 2019 at the Fallbrook site located in Carbondale, Lackawanna County. Fallbrook is an innovative and complex development that will be constructed on 10.2 acres of land, which is located at the site of the former Carbondale General Hospital. The development will incorporate 36 units of inter-generational housing, an outdoor walking trail, a community garden, and five multipurpose community rooms. United Neighborhood Centers plans to relocate the Carbondale Active Older Adult Center to the site, which will allow us to provide many social services to the residents of the greater Carbondale community.
